The Volcano CSD had two wells. The district has spent a lot of money to get the wells back online but has more work to do. One well is producing water but the water needs to be treated and the district engineers are working with the state water board to find a fix, and one has not yet been determined. The wells have never been big producers. Until the wells are back online, the district only has one water source for now. Conservation measures are being put in place and will be by the end of the month. Many households are one-person households. It is difficult for water use to be reduced to 1650 gallons per person, per month. There are a few businesses in town and they require water for health and safety reasons, especially with the COVID situation, washing and sanitizing are essential Ten percent of the district properties are commercial properties.
