WHEREAS, the Volcano Community Services District (VCSD) adopted Ordinance 2015-01, which adopted the policy to transfer any outstanding balance for water services, from the previous calendar year, to Amador County for collection through the property tax system, and

WHEREAS, the District will follow the county timing and protocol for the transfer of the outstanding balance, and any cost to the District for this method of collection will be transferred to the property owner, and

WHEREAS, there are customer balances owing for charges incurred from 2023,

NOW THEREFORE, BE IT RESOLVED AND ORDERED, the VCSD treasurer or other designee that the VCSD appoints for this purpose will follow through with sending those 2023 balances to the county for collection in accordance with Ordinance 2015-01.


